DUTIES:

This position is primarily responsible for analyzing and monitoring financial performance of the Directly Operated and Purchase of Service Centres, reviewing and analyzing all quarterly and year-end reporting requirements in accordance with Ministry of Children and Youth Services, calculating Wage Subsidy Funding entitlements on an annual basis, performing financial reviews, and providing advice and guidance to child care providers. Performs other related duties as required. Must maintain amiable relations with co-workers and customers. Perform Occupational Health and Safety duties, as outlined in the Corporate Health & Safety program. Performs other related duties as required.
